The election meeting cannot be held without the proper quorum; therefore, it is important that you complete and return the proxy, if you are not able to vote or attend the meeting. **Write-in candidates or floor nominations are not accepted for virtual meetings.**

You may now cast your Ballot online; a Ballot cast electronically shall also count for quorum, therefore, if you vote online, please do not assign your proxy to another person as it will not be counted. If you do not vote online, it is important that your Ballot or Ballot and Proxy be returned no later than 5:00 p.m. on Wednesday, January 17th, 2024, for it to be counted.
